The terms of reference of the above committee shall be as follows;

- The Committee shall fully adhere to the UGC (Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Education Institutions) Regulations, 2015.
- Any complaint of sexual harassment, if received, by the undersigned shall be forwarded to the Committee and shall immediately act upon it as per the above Regulations
- The Committee shall keep all the original records pertaining to the cases in safe custody with its record in a Register and prepare Annual Status Report with details of the number of cases filed and their disposal and submit the same to the undersigned for forwarding the same to the Commission, UGC.
- The terms of ICC shall be 03 (three) years. However, the term for the student representatives is for a period of one year. They shall cease to be a member of the Committee in case they lose their status as a student of this Institution. The student representatives shall be called to attend the meeting of ICC only when the matter involves student(s).
