**Resolution 1.**

**Resolution 2.**

The credit Calculation formula for the subjects will be the same as mentioned in UGC Guidelines for B.Voc Degree Programme i.e., One Credit would mean equivalent of 15 periods of 60 minutes each, for theory, workshops/labs and tutorials.

**Resolution 3.**

The assessment for the general education component should be done by the College and the question papers setting and evaluation be done by the members of the BOS Members constituted by the Dibrugarh University.



***Terms of Reference:***


1. *The Board of Studies shall prepare the syllabi of the General Components (non skill) of the B.Voc Programme in Choice Based Credit System.*

5. *The terms of the Committee shall be of three years or further notification which ever earlier.*


