of incumbents holding the post of lecturers in the defference Deptt.
fulfilling the present U.G.C. norms for appointment as lecturers as per
Govt. of India's letter No.F.1-21/87/111, dt.17-6-87 their letter
of even No. dt. 22-7-88, Govt. of Assam in the Education Department's
letter No.EPG.559/87/Pt-III/87-A dt.15-12-88, No.EPG.559/87/223, dt.6-8-89
and EPG.559/87/Pt-III/187, dt.6-3-90 as shown in the statement enclosed
are hereby provisionally approved w.e.f. 11-1-96 against the posts
sanctioned vide Govt. letter No.PMA.188/95, dt.11-1-96.

As. such the appointment of the incumbnet holding the post of non-teaching staff as shown in the statement enclosed are also provisionally approved w.e.f. 11-1-96. They are also entitled to draw the minimum of the time scale of pay and other allowances as admissible under rules w.e.f. 11-1-96 or from the date of approval of their appointment which ever is later.

In the aforesaid statement some posts have been shown as vacant as the posts are either actually vacant or the incumbents holding the posts do not possess to present U.G.C. norms. Vacant posts may be filled up after observing all formalities as per U.G.C guide lines and Departmental proceedure & norms. As regards Department's Headship allowances necessary proposal for this purpose with specific resolution of the G.B. indicating the Head of the Deptt. should be furnished to the D.P.I, Assam for sanction of Headship allowances. In determining the Head of the Deptt., seniority in servide be strictly followed. The deptt. having affiliation upto T.D.C. Part-II level of G.U./D.U. with prior concurrence of the Govt. will be admissible for Headship allowanced, if there are more than one approved teacher posts sanctioned for the subjects which are common to both Arts, Science and Commerce Streams as the case may be.

All the lecturers must appear before the state selection board, Assam for their selection and subsequently be approved by the Govt. If any body is not selected by the S.S.B., Assam, as well as not approved by the Govt. his/her service will have to be terminated by the G.B. of the College.

It may be noted here that the appointment approval are hereby provisional. As such necessary proposal for formal approval of appointment of all teaching and non-teaching staff as shown in the enclosed statement should invariably be submitted to this Directorate at the earliest alongwith the undersigned documents.

- 1) G.B.'s resolution for appointment of the incumbent at the adhoc stage of the college.
- 2) G.B.'s resolution for regularisation of the appointment under deficit system of G.T.A. w.e.f. 11-1-96 or thereafter as the case may be.

- 4) All certificate and marksheets of the incumbents duly attested by a Gazatted officer from H.S.L.C. onwards.
- 5) Police verification report on the character and antecedent of the incumbents and P.R.C. as the case may be.
